INSPECTION FORM: ADVANCEMENT TO FOUNDATION BROOD BOOK

This inspection is for advancement into the Foundation Brood Book of the American Blazer Horse Association, Inc. Brood Book advancement is required for stallions and mares in order to produce registerable offspring. **This form must be signed by a licensed veterinarian.**

OWNER INSTRUCTIONS

1. You must be an current America Blazer Horse Association (ABHA) member to advance your horse to the Brood Book or transact any Registry business with the ABHA. An additional \$35 membership fee will apply if not a current member in good standing.
2. Fees for both the veterinarian's visit and the administrative fees are the responsibility of the owner.
3. Have your veterinarian complete page two (2) and sign this form.
4. Show your horse's current registration paper to your veterinarian.
5. When inspection is completed, mail completed form, original registration papers and appropriate fees to the American Blazer Horse Association office.
6. Advancement fees: **\$30 for a mare, \$125 for a stallion.**
7. Once approved for advancement, you will receive a new registration certificate.

Description of an American Blazer Horse:

- *A gentle and willing disposition*
- *Standing between 13 and 15 hands at maturity*
- *A refined head with bold eyes that set well out on the corners of the head*
- *Well sloped shoulder*
- *A short back to carry weight*
- *long hip for more power*
- *Good flat bones with strong legs; medium-length pasterns*
- *Solid non-albino colors (no pinto or appaloosa characteristics).*
- *No white markings above the knee/hock, except on face.*
- *Eyes should be a shade of amber, brown, or black. Horses with no partial or full blue eyes or whose eyes lack all pigments (appear pink) may NOT be registered.)*
